Personal information collected at the time of an inquiry will never be sold to outside parties.

The term “Third Party” used in this Privacy Policy means any entity other than **Mystical Dream Travel**.

## Collection and Use of Personal Information from Web Site Users

Like most web servers on the Internet, our servers collect and store all of the information that your web browser sends when it requests a web page, including the home server domain names, type of computer, and type of Web browser of visitors to the Site. It is impossible to determine the actual identity of an individual user from this information.

When you send us personal identifying information via e-mail (that is, in a message containing a question or comment, or by filling out a form that e-mails us this information), we use it to:

- respond to your requests
- send you important information, regarding your relationship with you or regarding the site, changes to terms, conditions and policies and/or administrative information
- marketing communications, such as our newsletter.
